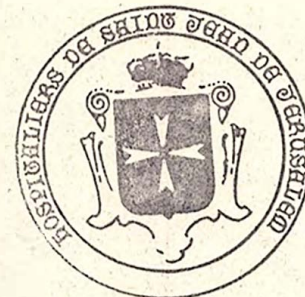
General Manager of all World Financial Banking Assets, as the Main Regulator of the entire World Banking System.
