## Decree

By God's Grace,

By Right of the Supreme Sovereign,

I hereby proclaim,

Worldwide multifunctional Global Payment System SunPay M 1

I hereby declare:

To the Sovereign International Treasury Monetary One, as the Absolute Owner and Main Regulator of the entire World Financial System, by Right of the Sovereign being the Absolute Owner and Manager of All World Assets in the entire World on the basis of the Exclusive Historical Right from the Creator of the New Era, as well as to the World Sovereign Bank of the Order of Hospitallers, as the Main Historical Bank of the World, the Main Regulator of the World Banking System and the General Manager of All World Financial Banking Assets:

1. To carry out all necessary registrations and issue all necessary permits and Licenses, in accordance with the Sovereign Legal Acts of the Sovereign International Treasury Monetary One and in accordance with the Sovereign Legal Acts of the World Sovereign Bank of the Order of Hospitallers, the SunPay M1 World Payment System, for the implementation of full-fledged activities in the areas of the World Payment System in the full unlimited range of use of payment monetary and currency technologies.

2. The World Sovereign Bank of the Order of Hospitallers, as the Main Historical Bank of the World, the Main Regulator of the World Banking System and the General Manager of All World Financial Banking Assets, shall open special, systemic, clearing and multifunctional accounts:

- check USDB (Dollar backed by XAU under the Basel III Standard);
- check Gold Dollar;
- check Gold Soviet Ruble;
- check Gold Pecun.

3. The SunPay M1 World Payment System, in the World Sovereign Bank of the Order of Hospitallers, for the implementation of clearing monetary and currency coverage, initially place the following amounts on the above-described accounts:

- USDB Account – 10 trillion USDB (Dollar backed by XAU under the Basel III Standard);
- Gold Soviet Ruble – 10 billion (Gold Standard);
- Gold Dollar – 10 billion (Gold Standard);
- Gold Pecun – 10 billion (Gold Standard).

This Sovereign Decree has the status of the Supreme Sovereign Unconditional Legal Act and comes into force from the moment of its signing.
